XI/05/2010/869/RC# # # # In exercise of the powers conferred under Article 229 of the Constitution of India, Hon'ble the Chief Justice of the Gauhati High Court [High Court of Assam, Nagaland, Meghalaya, Manipur, Tripura, Mizoram and Arunachal Pradesh] is pleased to make the following amendments in Schedule-1 of the Gauhati High Court Rules, 1967 [hereinafter called the Gauhati High Court Services (Appointment, Condition of Services and Conduct) (Amendment) Rules 2011], regarding PAY AND CADRE OF HIGH COURT SERVICE AND POSTS, in Category III and IV, respectively.

1. Short title and commencement:-

- (I) These rules may be called "the Gauhati High Court (Amendment) Rules, 2011.
- (II) They shall come into effect from the date of issue of the Amendment Notification.

2.

- (I) In amending the SCHEDULE-1 [PAY AND CADRE OF HIGH COURT SERVICE AND POSTS] in Category III, pertaining to NON-MINISTERIAL ESTABLISHMENT CLASS III (C), the posts of 'Barkandaz' and 'Xerox Machine Operator', shall be inserted and be placed at Sl. No. IV & V, thereto, respectively, after the post of Electrician at Sl. No. III.
- (II) In amending the SCHEDULE-1 [PAY AND CADRE OF HIGH COURT SERVICE AND POSTS] in Category IV, pertaining to HIGH COURT SUBORDINATE SERVICE (CLASS-IV), the post of 'Barkandaz' in Sl. No. I and the post of 'Xerox Machine Operator' in Sl. No. V, stands deleted.

After above amendment, the category of posts in Class-III (C) and Class-IV, in the Gauhati High Court (ACC) Rules' 1967, shall stand serially, as follows:-
