<b>Stage</b>	<b>Description</b>	<b>Marks</b>
<b>Stage 1</b>	<b>Cooking Skill Test</b>	40 Marks
<b>Stage 2</b>	<b>Viva-voce/ Interview</b>	10 Marks
	Candidates equal to 3 times of the number of vacancies (1:3) in order of merit in the Cooking Skill Test will be called for Viva-voce/ interview.  The final selection will be made on the basis of the total marks obtained in the Cooking Skill Test and Viva-voce/ interview.	

N.B: The Gauhati High Court reserves the right to fix the cut off marks of the cooking skill test for calling candidates to Viva-voce/Interview. In case of candidates securing equal total marks, preference will be given to the candidate having higher mark in cooking skill test. In the event of securing equal marks in cooking test, the candidate who is senior in age will be given preference.


