No. HC.V-09/2018/186 /Estt.### Ms. Munmun Boruah is temporarily appointed in the post of **Senior Personal Assistant** in the Principal Seat of the Gauhati High Court, vice **Sri Anil Kumar**, in the revised scale of pay of Rs.22000-87000/-(PB-3) with Grade Pay of Rs.9100/- per month plus other allowances, as admissible under the Rules, with effect from the date of her joining, subject to the condition that in the event of adverse police verification report, her service will be terminated forthwith without assigning any reason whatsoever.

The service of the aforementioned candidate shall be governed by "The New Defined Contribution Pension Scheme" issued by the Government of Assam, Finance (Budget) Department vide office memorandum No.BW.7/2008/Pt/40, Dtd. Dispur the 6th October, 2009. The selected candidate mentioned above will have to submit an undertaking to that effect at the time of joining the Registry of the Gauhati High Court, Guwahati.

She will be on probation for a period of one year with effect from the date of her joining. She is directed to join duty within 15 (fifteen) days from the date of receipt of this order.

Further, she is directed to submit her medical certificate of fitness from Medical Officer of Govt. or from any Medical-Officer-in-charge of a Civil Station and submit the report to this Registry at the time of joining.

Ms.Boruah is further directed to submit release order from the former employer at the time of joining, if presently, employed in Central/ State Government service.
