**NOTICE**

Computer skill test for engagement of 4(Four) contingent workers for typing and data entry work in terms of advertisement dated 5-10-2012 shall be held in the principal seat of Gauhati High Court on 15-12-2012(Saturday) from 10.00 am till 5.00 pm. In the event of non completion of the computer skill test on the said date within the stipulated time, the remaining candidates shall be tested on 17-12-2012(Monday) from 10.30 am onwards in the Recruitment Cell of Gauhati High Court. The candidates bearing Roll Nos from 1 to 68 and 69 to 136 mentioned in the list of candidates published in the Gauhati High Court website are hereby directed to report to the undersigned at 9.30 am (for candidates bearing Roll Nos from 1 to 68) and 12.00 pm (for candidates bearing Roll Nos from 69 to 136) respectively on 15-12-2012(Saturday).

The Computer Skill Test (100 marks) shall be conducted for 20(Twenty) minutes in batches of approximately 20 candidates to test the ability to use spread sheet on MS Excel as well as typing speed and accuracy in word processing in MS Word (Word Processing test shall be conducted on a software designed for that purpose). Candidates will be required to complete both the components of the computer skill test (word processing and use of spreadsheet) within the stipulated 20(Twenty) minutes. At the end of the stipulated 20(Twenty) minutes two printouts (One each of both the components of the skill test) shall be taken out for evaluation.

No individual Admit Card shall be issued to any candidate for appearing in the aforementioned computer skill test.

It is further notified that all the candidates, who submitted applications within 20-10-2012(Last date of submission of applications) as per the advertisement, are being called for the computer skill test as mentioned above, except those candidates who submitted applications after due date by post and in the drop box. The candidates are being called after only preliminary scrutiny of their applications. Please note that candidature of the applicants shall be subject to fulfillment of all the criteria mentioned in the advertisement dated 5-10-2012. No T.A/D.A will be paid to the candidates. Calling of the candidates for computer skill test does not necessarily mean acceptance of their candidatures which shall be further scrutinized.
