Pursuant to the advertisement dated 10/06/2019, the Gauhati High Court has been pleased to notify the Selection Process as well as the Schedule of the Interview/Viva-voce for recruitment to **221 (Two hundred twenty one) post of Members, Foreigners Tribunal, Assam.**

### **Selection Process:**

Candidates shall have to appear in an interview of 100 marks. Candidates will be assessed on their General Personality, Professional and Social Standing, Knowledge of Law and General Awareness. Candidates will be selected on the basis of marks obtained in the Interview. Candidates shall have to secure a minimum of 60% out of total of 100 marks to be considered in the merit list. Date and time of interview/ viva-voce of the selected candidates shall be as per schedules published with this notification. Eligible candidates have to note down the Roll No. from the select list uploaded with this Notification. The decision of the Interview board will be final.

Original Documents regarding experience, educational qualifications, other qualifications, eligibility, NOC (if any) from the parent organization, Enrollment Certificate, Proof of employment and Proof of last post held etc. will be required to be produced at the time of interview. Candidates shall also bring 3 (three) passport size Colour photographs at the time of interview along with the aforementioned original documents. The candidates shall also bring a set of self attested Xerox copies of all the original documents.

Original documents of candidates will be compared and verified by the High Court at the time of interview and at subsequent stages.

*(Note: In case of candidates obtaining equal marks (in viva-voce), one who is senior in age will be given preference.)*


