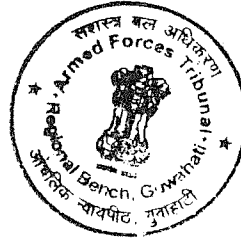
REQUIREMENT OF STAFF IN THE ARMED FORCES TRIBUNAL (REGIONAL BENCH) GUWAHATI



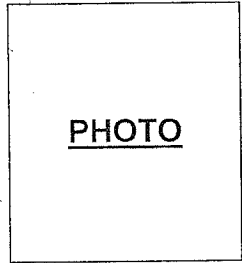
