To appear in the examination, the candidates shall bring to the Examination Hall the Admit Cards, Fee Payment Challan (Candidate's Copy) along with black/blue ball point pen. Venue of the examination will be indicated in the Admit Card along with other details.

Allowing the candidates to appear in the preliminary examination does not necessarily mean acceptance of their candidatures, which shall be further scrutinized and Gauhati High Court reserves the right to reject the candidature of any candidate at any subsequent stage of the selection process .


