It is most respectfully submitted that

This year in the Annual Calendar Meeting it has been decided to make the NJA more of a training of trainers institution for the effective training to be given through the state judicial academies.

As the NJA is seeking to employ 4 Assistant Professors for its 21-member faculty team, it was thought that these 4 positions could be offered to judges from all over India on deputation for a period of one to two years so as to simultaneously train these judges for strengthening the state judicial academies on their return from the NJA.

The NJA would be grateful if Your Lordship could forward the application of any of the bright judicial officer to work as Assistant Professor on deputation for a period of one /two year/s. This officer after working as an Assistant Professor at the NJA Bhopal can be absorbed by the State Judicial Academy for helping in the designing of effective delivery of training programmes so as to allow him/her to apply his/her learning on the training methodology.

Once the application of bright judicial officer is received from Your Lordship's jurisdiction, the same along with other applications from other high courts would be forwarded to the Hon'ble Chairperson of the National Judicial Academy the Hon'ble Chief Justice of India. The final selection would be made in the Supreme Court of India by the Selection Committee constituted by the Supreme Court of India.

The NJA would be grateful to Your Lordship for rendering help in this matter. The undersigned would be highly obliged if Your Lordship could take action on this matter on or before 30 June 2015 so that the Committee is constituted at the Supreme Court at the earliest to select Assistant Professors for the National Judicial Academy.
