
In case of candidates securing equal same grand total marks, the candidate who obtained more marks in the Stenography test has been given preference and where the marks obtained by such candidates in the Stenography test are also same, the candidate who is senior in age has been given preference in terms of the notified selection process.

The above select list shall remain valid for a period of one year from the date of declaration of result.

The appointment letters to the selected candidates will be issued by the concerned appointing authorities in due course. After issuing appointment letters/ joining of selected candidates, police verification will be initiated by the concerned appointing authorities. In the event of adverse police verification report (s), the services of appointed candidate(s) will be liable for termination.

The marks of written test, stenography test and the viva-voce have been uploaded, along with this notification in the High Court website, for information of all concerned.
