
The test of typing speed and accuracy in word processing will be conducted through a website www.10fastfingers.com or www.typingtest.com or any other such free website or any other offline application software. Candidates will be required to type for 1(one) minute and at the end of one minute, the number of correct words/net speed he/she can type within one minute will be recorded. 1(one) mark will be awarded for every word typed correctly/net speed. A candidate will be allowed 2(two) attempts of 1(one) minute each and the marks obtained in the best of the 2(two) attempts will be considered for final evaluation.

Candidates are directed to bring all testimonials, acknowledgement slip of online application, admit card of Common Written Examination, two recent passport sized coloured photographs, work experience certificate, if any, etc., in original, along with a set of self-attested photocopies. The self-attested copies shall be handed over to the Joint Registrar (Recruitment) at the time of Computer Skill Test.

In the event of his/her final selection, the candidates who are presently employed in Central or State Government services, will be required to produce a No Objection Certificate (NOC) from the present employer.

Calling of the aforementioned candidates to the Computer skill test is purely provisional and does not mean acceptance of their candidature, which shall be further scrutinized and the High Court reserves the right to reject the candidature of any candidate at any time. The candidature of the candidates shall be subject to fulfillment of all the criteria mentioned in the advertisement dated 6-8-2015. No TA/DA will be paid to the candidates.


