No. HC.V- 27/2014/556/Estt (Pt-II). # # # The following daily wage workers are temporarily regularized in the following Grade-IV posts in the Principal Seat of the Gauhati High Court, Guwahati as per the Resolution No.i of the Item No.2 of the meeting of the Committee for Centralized Recruitment for Officers and Staff of Subordinate Judiciary and All Benches of the High Court held on 05.03.2014, in the usual scale of pay of Rs. 4560-15000/-(PB-1) with Grade Pay of Rs 1500/-per month plus other allowances as admissible under the Rules with effect from the date of their joining, subject to condition that in the event of adverse police verification report, their services will be terminated forthwith without assigning any reason whatsoever.

Dispur the 6th October, 2009. The selected candidates mentioned above will have to submit an undertaking to that effect at the time of joining the Registry of the Gauhati High Court, Guwahati.

They are directed to join their duties within 15(fifteen) days from the date of issuance of the order.

They will be on probation for a period of 1 (one) year from the date of their joining.
