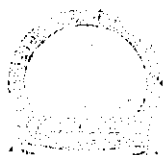

# JUDICIAL ACADEMY, ASSAM

## General Instructions on online classroom training

1. The online classes shall be conducted by using the Online Meeting Software "**Microsoft Teams**" which will be **two-way audio-video interaction**.
2. Trainee officers are to join via the Joining Link intimated through individual email.
3. Trainee officers are requested to report online through joining Link, at least 15 minutes before the scheduled time and to maintain punctuality.
4. Trainee officers are advised to use their Laptop/Smartphone for attending the online classes.
5. All the Trainee officers are directed to follow the below protocols: -
  - a. Keep themselves **muted until & unless** they are directed by the faculties/resource person to unmute themselves.
  - b. Ensure proper Internet connection with adequate data so that they can attend the classes without any network and connectivity issue.
6. The Trainee officers are to wear **formal attire** (befitting an officer) while attending classes.
7. Joining Instruction (steps below are to be followed):
  - Click on the given link or type the given link on the browser. A new tab with a pop-up will open.
  - Select 'Open Microsoft Teams' if you have Microsoft Teams App already installed in your device. It is recommended to join through App for better experience.  
OR  
Cancel the pop-up and click on 'Continue on this browser'. Then type your name and join.
  - For joining through Smartphone, Microsoft Teams App needs to be installed before joining the training
