Apart from Health Care, Food, Economy and Education, the COVID-19 had its adverse effect on the Judiciary too.

With a view to containing the spread of the virus, a steadfast course of actions was required and extensive restrictions were imposed on every sector and every activity of the nation. In view of the scale of disruption caused by the pandemic, it was found necessary to vaccinate all the people of the country immediately so that the nation can decide the future course of action to contain

the virus and combat with the Covidravaged economy. The Chief Justice of the Gauhati High Court also took cognizance of the situation and issued a clear directive to all employees over the age of 45 to get vaccinated. Following that, the inoculation of Covid-19 vaccine kicked off at the Gauhati High Court on 17<sup>th</sup> April, 2021. Initially, around 100 employees of the Gauhati High Court were enlisted in the

vaccination list. Later on, more and more people were included and were vaccinated on daily basis. Until now, the Covishield vaccine (developed by Serum Institute of India) has been administered. As a precautionary measure, a medical team, along with a well-equipped ambulance and packaged drinking water, has

been arranged and 45 minutes of observation has been made mandatory for emergency situations that may arise post-vaccination.

In the second phase, the employees of the Gauhati High Court in the age group 18 to 45 have been vaccinated. The Gauhati High Court, in an effort to beef up immunization, also included the dependents of the employees in the vaccination campaign.

# Chief Justice's Residence declared as 'Living Heritage Building' on 20th July, 2021

On the 20th of July, 2021, the Governor of Assam, vide an order, declared the residence of Chief Justice of the Gauhati High Court, Guwahati as a living heritage building to protect and preserve it as per the Assam Ancient Monuments and Records Act, 1959, the Assam Ancient Monuments and Records Rules, 1964 and the Assam Heritage

(Tangible) Protection Preservation, Conservation and Maintenance Act, 2020.

The Hon'ble Chief Justice's residence is situated in a plot of land measuring 8 bighas 15 lechas at Guwahati under Guwahati Revenue Circle, Kamrup. It is amongst the oldest and few standing examples of the unique Assam type architectural houses which were in vogue during the 19th and 20th century in Assam. This bungalow is almost a hundred and twenty years old. On the 14th of July, 2021, a Cabinet Memorandum was passed to protect and preserve the residence of the Hon'ble Chief Justice of the Gauhati High Court as a living heritage building. This double storied bungalow was built by the colonial administrators as their then residence, which was later turned into the residence of the Hon'ble Chief Justice of Gauhati High Court. Presently, it stands as one

of the few such houses in the city with its iconic architectural elements and design. The historic bungalow was constructed as per traditional building construction techniques basic building materials which were mostly locally sourced. The bungalow has a beautiful wooden façade the front, built originally using ekora (reed) and mud-lime

plastered walls. It has mud-lime plastered flooring in the ground floor and wooden flooring on the first floor. The main framework of the bungalow was erected with reinforced steel columns and beams, which became a distinct addition after the earthquake of 1897. This made the buildings resilient against future earthquakes. It also features a chimney which runs through the center of the house and four fireplaces accommodated in the living room and bedrooms on both the ground and first floor. On the interior, a wooden staircase is beautifully carved with intricate patterns. Through the years, necessary repairs and renovations have been carried out, yet its grandeur is kept intact and preserved. Past residents have used and enjoyed this building in a very different way while in later period, residents mostly intend to use it with all available modern facilities. In some cases, the surface finishes are also altered as per the choice of the present years without paying much attention to the compatibility of such alterations to an old building on the internationally accepted principles of construction of historic buildings. As a result, conservation of this building has become more difficult and challenging. Conservation of historic buildings requires specialized skill. Understanding the building and its original construction etc. is important before taking up any repair as maintenance work to these buildings. Now as it is a 'Living Heritage Building', stability and strength of the structure would be checked regularly. For conservation of this historic building, even skilled conservator from outside the state who is well-experienced in such type of conservation works in India and abroad, can be outsourced, if necessary. The Directorate of Archaeology will be in the best position to aid in these works. Now a MOU is to be signed between the Directorate of Archaeology, Assam and the Hon'ble Gauhati High Court Authority. After signing the MOU, the notification will come into force on the date of its publication in the official Gazette.

# Allotment of Quarters among the Senior Private Secretaries Grade-I on 29th July, 2021

On 29<sup>th</sup> July, 2021, the Hon'ble Chief Justice Sudhanshu Dhulia distributed the keys of Gauhati High Court quarters among the Senior Private Secretaries Grade I.
