From the Chief Justice

I sincerely hope that the worst of Covid-19 pandemic is now behind us. As we look forward then to regular working in our Court rooms and Chambers, we must now plan and work out methods to best utilize our court hours to decide the pending cases, which have accumulated during this pandemic. I expect the Bar and the Bench to cooperate in this matter and come



out with solutions to bring the arrear of cases at a manageable level.

At the same time, I say with some satisfaction that during the past one year or so new judicial districts have been formed and better infrastructure has been created, at least in some places. Hojai, Charaideo and South Salmara are the new judicial districts which became functional last year. Bajali, Majuli and Biswanath will become functional as new district courts very soon.

In Mizoram till very recently out of the nine administrative districts, we had only two judicial districts. We have now a third judicial district in 'Champhai', which became functional on 11th November, 2021. A new Court building is now functional for the District Court at Golaghat in Assam. Similarly, two new court buildings have been constructed and are now functional at 'Wokha' and Zunhebotto districts in Nagaland. The new Court building at Barpeta is also ready. In the High Court construction will soon start for eight new Court Rooms. There is also a proposal for creating clean, hygienic and comfortable cafeteria and rest rooms for senior advocates and advocates, who are practicing in the High Court. A 'Creche' for working mothers in the High Court has just been inaugurated. This may need expansion in future. The basic work for the High Court Museum has also been completed and it should be soon open for public. Looking forward. With Best wishes.

As a part of this initiative taken by the Supreme Court of India, the Gauhati High Court has also created an e-Sewa Kendra for rendering hassle free services to the litigants.

On 3rd March 2022, Hon'ble Chief Justice Sudhanshu Dhulia of the Gauhati High Court inaugurated an e-Sewa Kendra in the Old Block of the Principal Seat of the Gauhati High Court in presence of Hon'ble Mr. Justice N. Kotiswar Singh, Judge, Administrative Department, Gauhati High Court; Justice Suman Shyam, Judge, Gauhati High Court and Chairperson, ICT Committee, Gauhati High Court, other Hon'ble Judges of the Gauhati High Court, learned Advocate General of

Mizoram, the Standing Counsel of the Gauhati High Court, Chairman, Bar Council of NE States, Lawyers and officials of the Registry.

The main objective of the e-Sewa Kendra is to facilitate those services to the litigants as well as the lawyers which are vital for the better functioning of the Court. The e-Sewa Kendras shall initially roll out following services for litigants and lawyers--

- o Handling inquiries about case status, next date of hearing and other details.
- o Facilitate online Applications for certified copies.
- o Facilitate e-filing of petitions right from the scanning of hard copy petitions, appending e-signatures, uploading them onto CIS and generation of filing number.
- o To assist in online purchase of e-Stamp papers/e-Payments.
- o To help in applying and obtaining Aadhaar based digital signature.
- Publicize and assist in downloading the Mobile App of e-Courts for Android and IOS.
- o Facilitate in the booking of e-Mulakat appointments for meeting relatives in jail.
- o Handling queries about Judges on leave.
- o Guide people on how to avail free legal services from the District Legal Services

- Authority, High Court Legal Services Committee and Supreme Court Legal Services Committee.
- o Facilitate disposal of traffic challans in virtual Courts as also online compounding of traffic challans and other petty offences.
- o Explaining the method of arranging and holding a video conference court hearing.
- o Provide soft copies of judicial orders/judgments via email, WhatsApp or any other available mode.

The creation of the e-Sewa Kendra, in brief, stands out as a significant step for the lawyers in handling the cases and for the common man in his claim for justice.


