





#### MACT Portal Launch on 11th May, 2024

On the 11th day of May, 2024, Chief Justice Vijay Bishnoi inaugurated the Motor Accident Claim Information Portal. The event took place in the Judges' Conference Room, coinciding with the eve of the National Lok Adalat. The inauguration ceremony was graced by the presence of other

The Motor Accident Claim Information Portal stands as a beacon of citizen-centric service, providing a comprehensive platform for accessing vital information pertaining to motor accident claim litigations. This initiative reflects the judiciary's commitment to leveraging technology for the betterment of legal processes and ensuring access to justice for all. One of the portal's notable features is its claim calculator which provides advocates and litigants with a tentative compensation amount. This invaluable tool serves as a reference point for MACT (Motor Accident Claim Tribunal) cases, aligning meticulously with the prevailing guidelines set forth by the Supreme Court of India. Notably, it draws inspiration from landmark cases such as Sidram vs. The Divisional Manager UIIC Ltd, Sarla Verma, Pranay Sethi, and Magma General Insurance Co Ltd. One of the notable features of the portal is its bilingual interface, catering to the diverse linguistic landscape of the State. Additionally, the portal elucidates the rights of victims in a clear and concise manner, empowering them with

knowledge and understanding of their entitlements in the aftermath of a motor accident. To enhance experience user and comprehension, the portal also features an informative bilingual video elucidating its functionalities and utility. This video serves as a valuable resource for users,

offering visual clarity and step-by-step guidance on navigating through the portal's offerings. In essence, the Motor Accident Claim Information Portal symbolizes a paradigm shift in dissemination of legal information and facilitation of MACT cases. By amalgamating technology with legal expertise, it not only streamlines processes but also democratizes access to legal resources, thereby, upholding the principles of justice and equity.
