The central message was the establishment of Rule of Law, by systematic revamp of the Institution of Judiciary, the indispensable and most vital organ in the structure of administration justice, within the resources of





## Training Programme on Mediation and Conciliation for Chairman and Mediators of Permanent Lok Adalats in Assam

Gandhiji in his autobiography wrote — "My joy was boundless. I had learnt the true practice of law. I had learnt to find out the better side of human nature and to enter men's hearts. I realized the true function of a lawyer was to unite parties driven as under. The lesson was so indelibly burnt into me that a large part of my time during the twenty years of my practice as a lawyer was occupied in bringing about private compromises of hundreds of cases. I lost nothing thereby — not even money, certainly not my soul."

The abiding philosophy of Gandhiji is found reflected in the process of resolving disputes through Mediation, which is now statutorily mandated in India. With the amendments made in recent years in the Code of Civil Procedure, Mediation is the vehicle of choice for resolving of disputes. To give fillip to Mediation efforts, the Assam State Legal Services Authority under the aegis of National Legal Services Authority conducted a 40 Hours training programme on Mediation and Conciliation for Chairman




The sessions in the seminar stressed for better discharge of obligations by all the stakeholders to make aspirations of the nation into a living reality.






