# NOTIFICATION

## Dated Guwahati, the 29th April, 2025

The Hon'ble Gauhati High Court is pleased to issue the following guidelines regarding the issuance of certified copies of documents by the copying section:

1. While issuing certified copies of documents containing illegible words/lines/digits etc, a note should be made at the bottom of the certified copy stating the illegible portion occurring between or any side of the readable words/lines/digits etc.

The specific number of the line, wherever applicable (For instance, line no. 7 of page no. 2) in which the illegible portion appears should also be mentioned in the note.

2. In the event the applicant of certified copy approaches the Copying Section for physical certified copy which is to be prepared from a digitized copy, the Copying Section will issue the same by using the new seal that reads "Prepared from DIGITIZED copy"

However, in case of online applications, the applicant shall only be entitled to e-certified copy sent online pursuant to his/her application and no physical copy shall be provided by the copying section to any applicant of e-certified copy.

In the event the applicant requires a physical certified copy after applying for ecertified copy, the applicant has to make a fresh application for physical certified copy.

This shall come into force with immediate effect.
