No.HC.XI-08/2012/ 113 / RC #### In exercise of the powers conferred under Article 229 of the Constitution of India, Hon'ble the Chief Justice of the Gauhati High Court (The High Court of Assam, Nagaland, Meghalaya, Manipur, Tripura, Mizoram and Arunachal Pradesh) is pleased to make the following amendments to the Gauhati High Court Services (Appointment, Conditions of Service and Conduct) Rules, 1967 (hereinafter referred to as Principal Rules) to be effective from the date of notification.

1. These Rules shall be called the Gauhati High court Services (Appointment, Conditions of Service and Conduct) (1st Amendment) Rules, 2012.
2. In Rule 4, after the words "Schedule-I" and before the word "hereto" the words "Schedule-I(A), Schedule-I(B), Schedule-I(C), Schedule-I(D) & Schedule-I(DD)" shall be inserted and after the word "Assam" and before the word where, the words "/Tripura, as the case may be" shall be inserted.
3. In sub-rule (4) of Rule 7, after the word "Schedule-I(A)" and before the word "Shall", the words and Schedule-I(DD) shall be inserted.
4. In Rule 11, after the words "Schedule-I" and before the word "hereto", the word "Schedule-I(A), Schedule-I(B), Schedule-I(C), Schedule-I(D) & Schedule-I(DD)" shall be inserted.
5. Two new schedules, viz. Schedule-I(D) and Schedule-I(DD), shall be inserted after Schedule-I(C) as under:
