As per resolution adopted in the Hon'ble Full Court Meeting of the Gauhati High Court held on 05.06.2025, the following changes have been introduced to streamline the process of holding Full Court References on elevation/transfer/superannuation of Hon'ble Sitting Judges of the Gauhati High Court:

- 1. Whenever a Full Court Reference is to be held on elevation/transfer/superannuation of Hon'ble Sitting Judges of the Gauhati High Court, the Registry will initiate the same by placing a detailed note before the Hon'ble the Chief Justice or the senior most Sitting Hon'ble Judge of the Gauhati High Court, as the case may be.
- 2. The Registry will confirm, in writing, the list of Hon'ble Speakers who shall be addressing the Full Court Reference. For the same, the Registry will approach the Gauhati High Court Bar Association; Gauhati High Court Advocates Association; Bar Council of Assam, Nagaland, Mizoram, Arunachal Pradesh and Sikkim; respective offices of the Advocate Generals of Assam, Nagaland, Mizoram and Arunachal Pradesh; Deputy Solicitor General of India or Standing Counsel of Central Government, etc. to ascertain the list of willing speakers.
- 3. After the Registry is in receipt of the list of Hon'ble Speakers, the same will be placed before the Hon'ble the Chief Justice/senior most Sitting Hon'ble Judge of the Gauhati High Court, as the case may be, for approval of the number of Hon'ble Speakers and after approval, the list will be published indicating the date, venue and time of reference and the same will be published in the official website, in advance.
- 4. In addition to the above, Hon'ble the Chief Justice, may at his/her discretion, pass any further direction/order(s) for holding a Full Court Reference.

## This Notification shall come into force with immediate effect.

In case of holding of Full Court Reference on demise of any sitting and/or former Hon'ble Judge of Supreme Court of India or of Gauhati High Court or on demise of learned Members of the Gauhati High Court Bar Association and Gauhati
