dated 30/03/2012 in respect of Gr. I, Gr. II and Gr. III posts.

In partial modification of the OM No. FSI 5/2005/Vol VI/76 dated 30/03/2012 issued by Finance Department wherein it is stated in para 2 that responsibility of issuing prior approval for filling up of the required numbers of Gr. I, II and III existing vacant posts of different categories, excluding posts of teachers of Elementary Schools and drivers was delegated to Administrative Departments. Now, it is decided that the Administrative Departments shall henceforth be allowed to recruit the newly created posts of Gr. I, II and III of different categories excluding the posts of teachers of Elementary Schools and drivers without prior approval of Finance Department. However, if the Departments do not fill up newly created posts for 2 years from the date of creation, then the Departments have to take permission from the Finance (SIU) Department for filling up these newly created posts.
