In order to cope with the situation arising out of the second wave of COVID-19 pandemic, Hon'ble the Gauhati High Court has been pleased to extend this Registry's Notification No. 34 dated 01.05.2021 till 31.05.2021 with the following partial modifications/incorporations:

- 1. No Lawyer shall be permitted to come physically to the Court premises or to the Court Rooms for arguing of their cases. They shall argue their cases through virtual mode from their home, office or any other space.
- The facility given earlier by this Registry for conversion of hard copies to soft copies shall not exist from 10.05.2021 onwards and the Lawyers shall have to make their own arrangements for filing the petitions/documents digitally.
- 3. In case of an extremely exceptional situation, the learned counsel of the concerned party may approach Hon'ble the Chief Justice, for urgent hearing, or for constitution of a Special Bench.

The above measures shall come into force w.e.f. 10.05.2021 and shall be strictly implemented.
