

THE GAUHATI HIGH COURT AT GUWAHATI

(HIGH COURT OF ASSAM, NAGALAND, MIZORAM AND ARUNACHAL PRADESH)

ORDER NO. 57

Dated Guwahati, the 11th May, 2023

Hon'ble the Chief Justice has been pleased to allow the Judicial Officers of the Outlying Benches and District Courts under the Jurisdiction of the Hon'ble Gauhati High Court the option to either wear Nehru (half) coat or conventional suit and tie, during office hours and official functions, except while sitting in Court during the period from 1st April till 31st October.

It is further clarified that no Judicial Officer shall sit in Court without proper dress/ robe.

This notification will come into force with immediate effect.
