### ASSAM ACT NO. XXXVIII OF 2023

THE ASSAM APPROPRIATION (No. VIII) ACT, 2023

#### AN

#### ACT

to provide for the authorisation and appropriation of moneys out of the Consolidated Fund of the State of Assam to meet the amounts spent on certain services during the Financial year, 2010-11 in excess of the amount authorised or granted for the said services.

Be it enacted by the Assam Legislative Assembly in the Seventy-fourth Year of the Republic of India as follows:

**Short Title** 

1. This Act may be called the Assam Appropriation (No. Vill) Act, 2023.

issue of Rs.4,26,84,767.00 from and out of the Consolidated Fund of the State of Assam for the financial year, 2010-11.

2. From and out of the Consolidated Fund of the State of Assam the sums specified in column (3) of the Schedule amounting in the aggregate to the sum of Rupees Four Crore Twenty Six Lakin Eighty Four Thousand Seven Hundred And Sixty Seven shall be deemed to have been paid and applied to meet the amounts spent for defraying the charges in respect of the services specified in column (2) of the Schedule during the financial year 2010-11 in excess of the amount authorised or granted for those services for the year.

Appropriation

The sums deemed to have been paid and applied from and out of the Consolidated Fund of the State of Assam shall be appropriated for the services and purposes expressed in the Schedule in relation to the year ending on the Thirty First day of March, 2011.
