## CIRCULAR Dated Guwahati the 11th December, 2023

The Gauhati High Court has been pleased to formulate the following practices/procedures to be followed by the Judicial Officers of all the Districts of Assam while making communication to the Government relating to any matters:

- 1) The communication of the Judicial Officers of District Judge establishment / Chief Judicial Magistrate establishment to the Government will have to be forwarded by the District & Sessions Judges of their respective districts to this High Court for taking further necessary steps.
- 2) The Members MACT Courts/Principal Judges of the Family Courts/Presiding Officers Labour Courts/Industrial Tribunals shall forward any communications to the Government through the Gauhati High Court.
- 3) The Counsellors shall make any communications to the Government through their respective Presiding Officers, Family Courts and Presiding Officers, Family Courts shall forward the same through the Gauhati High Court.
