Dated Guwahati, the 15th May, 2020

Considering the changed scenario in the country and in view of certain relaxations provided in lockdown restrictions, and also taking notice of the fact that certain areas have been declared 'Containment Zones'/ 'Red Zones', Hon'ble the Chief Justice has been pleased to issue the following direction to be applied to all the Courts falling within the jurisdiction of the Gauhati High Court (in the States of Assam, Nagaland, Mizoram and Arunachal Pradesh):

- There shall be 'Restricted Court Functioning' with 'Staggered Roster'. 1.
- 2. The lawyers, litigants, court staff and any other person residing within the 'containment zones'/'red zones' in any of the States are expected to follow the orders passed by the administration; and not enter the court complexes till declaration of 'containment zones' in the area is lifted.

This direction shall be considered and read in continuance and partial modification of earlier directions.
