## NOTIFICATION Dated Guwahati, the 17<sup>th</sup> February, 2016

**No. HC.XI-03/2016/119/RC**: In exercise of the powers conferred under Article 229 of the Constitution of India, Hon'ble the Chief Justice (Acting) of the Gauhati High Court has been pleased to delete the following Note (1) and proviso appended to Rule 8 of the Gauhati High Court (Appointment, Conditions of Service and Conduct) Rules, 1967, with immediate effect:

"Note (1):- The Hon'ble High Court has reserved five percent of the posts for the members of the other backward classes and more other backward classes because already there is reservation of forty five percent for the members of the scheduled castes and scheduled tribes. The said reservations cannot be reduced. At the same time, increase in the percentage cannot be more than fifty percent.

Accordingly, it has been allotted five percent of the vacancies for other backward classes and more other backward classes."
