- 1. To supervise implementation of Mission Vatsalya with the help of State Protection Society (SCPS).
- 2. The Committee will prepare an annual action plan including financial proposal state and submit to the Ministry for approval.

- 3. The Committee shall closely monitor and review the working structures, serviprogress under various components of Mission Vatsalya and hold quarterly meetings with District Child Welfare and Protection Committees for elimplementation of the scheme.
- 4. The Committee with the assistance of SCPS may frame a media and communiplan to generate awareness among the public on various aspects of the Mission rehabilitation and procedures for better protection of children.
- 5. The Committee may rationalize the existing manpower in the implementing arterior optimum utilization of resources as per the number of blocks, case load and district transfers on need basis to address administrative exigencies.
- The Committee shall take needful measures for advocacy, awareness gene capacity building, of all stakeholders on child rights and child welfare, and a road-blocks, issues, complaints received regarding care and protection of child the State.
- 7. The State Committee shall make special efforts for convergence so as to benefits under all possible government welfare schemes for the children.
- 8. The State Committee shall ensure that all institutions are set under the Juvenile (Care and Protection of Children) Act, 2015, and Rules thereof.
- 9. The Chairperson may invite any other domain expert/ statutory body/ a departments to attend the meeting of the Committee.
