- i) In case of Single Bench matters, before the regular Bench as per roster;
- ii) In case of Division Bench matters, wherein both the Judges are no longer attached to this High Court, before the regular Bench as per roster;
- iii) In case of Division Bench matters, wherein one Judge is still attached to this High Court, before the Division Bench (if available) comprising of such one Judge, otherwise before a Division Bench as constituted by Hon'ble the Chief Justice.

This notification will come into force with immediate effect.
