No. HC.V-13/2011/ 612 /Estt. ### Whereas, the Gauhati High Court has framed the "Equal Opportunity Policy for Persons with Disabilities" for all the Courts under its jurisdiction vide its Notification dated 27-02-2024 pursuant to Section 21 of "The Rights of Persons with Disabilities Act, 2016"; read with Rules 8, 9 and 10 of Chapter-IV and Rules 12, 13 and 14 of Chapter-V of "The Rights of Persons with Disabilities Rules, 2017";

Whereas, Clause (2) of the Policy Statement of the abovementioned "Equal Opportunity Policy for Persons with Disabilities" mandates preparation of a list of identified posts in all groups suitable for Persons with Disabilities;

Whereas, the Gauhati High Court is committed towards eliminating all forms of discrimination (direct and indirect) and harassment and denial of reasonable accommodation to Persons with Disabilities;


