

SUB - REGARDING ISSUE OF MEDICO-LEGAL REPORTS, POST MORTEM REPORT, MEDICAL CERTIFICATES ETC

As per minutes of the meeting held on 28-08-17 at the office chamber of the Registrar General, the Hon'ble Gauhati High Court, you are hereby directed to follow the under mentioned instruction at the time of issue of Medico-legal reports, Post mortem reports, Medical Certificate.

- 1) The timeline for submission of medico-legal reports, post mortem reports is 3 (Three) to 7 (Seven) days.
- 2) The Doctors performing the post-mortem examination, medico-legal examination should mention his full name, address and contact number in the report itself.
- 3) Cases relating to crime against women, medico-legal examination should be done by female doctors as far as possible.
