Considering the recommendations made by the "Committee for considering opening of courts, or imposing restrictions on court functioning of the Gauhati High Court and subordinate Courts" as well as taking into account the inputs received from various sources including the Health Department and reports from the news agencies etc. regarding the present scenario of the COVID-19 pandemic in the district of Kamrup (Metro), Hon'ble the Chief Justice has been pleased to direct as follows:

- (i) Court work shall be restricted.
- (ii) There shall be staggered listing of cases before the Courts. Cases of all roster subjects will be listed. However, the cases which are in the final stage of hearing shall not be listed till such arrangement is modified.
- This shall come into force with effect from 31st August, 2020 (Monday) until (iii) further decision, subject to the COVID-19 situation in the District of Kamrup (Metro).
