No. HC.XI-06/2015/67/RC: In exercise of the powers conferred under Article 229 of the Constitution of India and in supersession of all Rules/ orders, Hon'ble the Chief Justice (Acting) of the Gauhati High Court has been pleased to amend/ modify the qualification for appointment of persons in Class IV (Group-D) posts in the Principal Seat of the Gauhati High Court and its Outlying Benches, in the following manner:

"A candidate for appointment to the post of Class-IV (Group-D) in the Service of Gauhati High Court and its Outlying Benches must possess the minimum educational qualification of Class-VIII standard; and those who have passed HSSLC or above shall be ineligible to apply for the said posts. Candidates possessing special skills may be given preference on need basis."

This shall be inserted as Rule 6(d) in the Gauhati High Court Services (Appointment, Conditions of Service and Conduct) Rules, 1967."
