Dated Guwahati the 28th April 2023

Hon'ble the Chief Justice has been pleased to issue the following directions regarding use of kitchen in Judges' Guest House at Kharghuli for convenience of the Guests residing in the Guest House.

- i) The big kitchen (Kitchen No-1) to be used as the common kitchen to cook both Veg and Non-Veg items (chicken, mutton, fish and egg) only.
- ii) The second kitchen (Kitchen No-2) is to be reserved for cooking non vegetarian items.
- iii) The third kitchen (Kitchen No-3) is to be reserved for cooking vegetarian items and the crockery and fridge of this Kitchen is to be identified separately and shall not be allowed to be used for any other purpose.
- iv) Boarders of the Guest House shall not in any way interfere with the functioning of the vegetarian kitchen.

This notification will come into force with immediate effect.
