The yearly Budget estimates for the Gauhati High Court are submitted to the Govt. of Assam for approval and allotment of budget/fund. Thereafter the Govt. allocates budgetary fund after discussion and voting in the Legislative assembly. The Govt. of Assam allocates sufficient funds to the District Judiciary and Gauhati High Court had never expressed its displeasure in writing on Budgetary allocation.



Rule 1 of Order XVII of CPC, which deals with grant of time and no such adjournment, shall be granted more than adjournments. The said provision is extracted below :

"1. Court may grant time and adjourn hearing. – (1) The Court may, if sufficient cause is shown, at any stage of the suit, grant time to the parties or to any of them, and may from time to time adjourn the hearing of the suit for reasons to be recorded in writing.

Provided that no such adjournment shall be granted more than three times to a party during hearing of the Suits.

However, Hon'ble Supreme Court in the case of ***Salem Bar Association Vs Union of India*** held that the provisions are directory.

Section 309 in The Code Of Criminal Procedure, 1973.

309. Power to postpone or adjourn proceedings.

(1) In every inquiry or trial, the proceedings shall be held as expeditiously as possible, and in particular, when the examination of witnesses has once begun, the same shall be continued from day to day until all the witnesses in attendance have been examined, unless the Court finds the adjournment of the same beyond the following day to be necessary for reasons to be recorded.
