further to amend the Assam Taxation (On Specified Lands) Act, 1990.

Preamble.

Whereas it is expedient further to amend the Assam Taxation (On Specified Lands) Act, 1990, hereinafter referred to as the principal Act, in the manner hereinafter appearing;

of 1990

It is hereby enacted in the Sixty-eighth Year of the Republic of India as follows:-

Short title, extent and commencement.

1. (1) This Act may be called the Assam Taxation (On Specified Lands) (Amendment) Act, 2017.
- (2) It shall have the like extent as the principal Act.
- (3) It shall come into force at once.

Amendment of Section 5.

2. In the principal Act, in Section 5, in clause (a), in sub-clause (ii), for the words, "fifteen paise", the words "ten paise" shall be substituted.

Amendment of Section 6A.

3. In the principal Act, in Section 6A, for the words "fifteen paise", the words "ten paise" shall be substituted.

further to amend the Assam Board of Revenue Act, 1962.

Preamble

Whereas it is expedient further to amend the Assam Board of Revenue Act, 1962, hereinafter referred to as the principal Act, in the manner hereinafter appearing;

It is hereby enacted in the Sixty-eighth Year of the Republic of India as follows :-

**Short title,
extent and
commencement.**

1. (1) This Act may be called the Assam Board of Revenue (Amendment) Act, 2017.

(2) It shall have the like extent as the principal Act.

(3) It shall come into force at once.

**Amendment of
Section 3**

2. In the principal Act, in section 3, for sub-section (7), the following shall be substituted, namely :-

“(7) No person shall be retained as member of the Board after he/she has attained the age of 62 years except for those members who are borne on a particular service, in which case, their date of retirement shall be governed by their respective service conditions.”
