10) A Parcticing Advocate of the State to be co-opted by the other members of the Committee for a period of five years and his term shall be co-terminus with the term of the Bar Council.

The members nominated by the Bar Council of Assam, Nagaland, Mizoram, Arunachal Pradesh and Sikkim under Section 4(3)(f) of the Assam Advocates' Welfare Fund Act, 1998 and as menioned in serial Nos. 6,7 and 8 hereinabove, shall hold Office for a term of five years or for the term of his membership in the Bar Council, whichever is less.
