Applications are invited from the serving Stenographers of the district courts of Assam, who are eligible as per the criteria indicated below, for participation in the promotional process for promotion to **Stenographer Grade-I** and **Grade-II** against the below mentioned vacancies in the District Courts of Assam.

1	Stenographer Grade-I	36
2	Stenographer Grade-II	28

**The earlier notification dated 27-02-2020 is hereby cancelled and the Stenographers who have applied earlier in terms of the notification dated 27-02-2020 shall have to apply again.**

**Eligibility criteria** (as on the last date of submission of applications):

(I)	For promotion to <b>Stenographer Grade-I</b>	Completion of 5 (five) years of service as Stenographer Grade-II or III, in the district judiciary of Assam.
(II)	For promotion to <b>Stenographer Grade-II</b>	Completion of 5 (five) years of service as Stenographer-III, in the district judiciary of Assam.

**Stenographers, who are working on contingent/contractual/ad hoc/wages basis etc., are not eligible to take part in the promotional process.**

Eligible stenographers, who furnish their options, will have to appear in a Speed Test as indicated below:



4.	Time for transcription of the dictated portion	20 minutes
5.	Candidates securing 30 or more marks out of 50 will be eligible for promotion to Grade-I

1.	Voice testing before dictation	2 minutes
2.	Speed test in Shorthand at a speed of <b>60 words per minute</b> (Duration 7 minutes) [420 words]	50 marks
3.	Time to be given to the candidates for testing the Computer	3 minutes
4.	Time for transcription of the dictated portion	20 minutes
5.	Candidates securing 30 or more marks out of 50 will be eligible for promotion to Grade-II


