- (ii) Paper-II: One paper of 100 marks duration regarding objective questions and problems of law as regards the Transfer of Property Act, Civil Procedure Code, Code of Criminal Procedure, Indian Evidence Act, Indian Penal Code, Limitation Act.
- (iii) Paper–III: One paper of 100 marks consisting of judgement writing (paper Book to be supplied), Legal theories on jurisprudence, provision of Constitution of India.

## 2. INTERVIEW: VIVA-VOCE - 50 MARKS.
