The scheme of the Computer Skill Test is as follows:

- A. At the start of the Computer skill test, the test of typing speed and accuracy in word processing may be conducted through a website <a href="www.10fastfingers.com">www.10fastfingers.com</a> or <a href="www.typingtest.com">www.typingtest.com</a> or any other such free website or any other offline application software. Candidates may be asked to type for 1(One) minute and at the end of one minute, the number of correct words he/she can type within one minute may be noted. 1(One) mark may be awarded for every word typed correctly. A candidate may be allowed 3(Three) attemps of 1(One) minute each and the marks obtained in the best of the 3(Three) attemps may be considered for final evaluation.
- B. Thereafter, test of ability to use spread sheet on MS Excel may be conducted by asking the candidates to prepare a one page (A4 size paper) chart in MS Excel (2007 or 2010 version) containing data within a period of 10 Minutes at the end of which the chart prepared by the candidate will be printed for evaluation. Candidates may be assessed on a scale of 40(Forty) marks for the said test in MS Excel.

No Individual Call Letter for the aforesaid test will be issued to any candidate.



Calling of the aforementioned candidates to the Computer skill test is purely provisional and does not necessarily mean acceptance of their candidatures, which shall be further scrutinized and Gauhati High Court reserves the right to reject the candidature of any candidate at any time.
