Specific venue of the examination will be indicated in the respective admit cards.


Admit cards may be downloaded from the official website of the Gauhati High Court (www.ghconline.gov.in) w.e.f **13.10.2020** (3.00 pm onwards). **No individual call letter will be issued to any candidate.**

Provisional list of candidates with assigned Roll Numbers have been published along with this notification. A list of candidates whose candidature has been rejected on the grounds mentioned against their names is also published. Candidature of the provisionally allowed candidates are subject to fulfillment of all the criteria mentioned in the advertisement dated 26.08.2020 and further scrutiny of the candidature shall be done at a later stage. The High Court reserves the right to cancel the candidature of any candidate at any stage on detection of any ineligibility condition.

It should be noted that no candidate will be allowed to enter the examination center without wearing a face mask. Candidates shall have to strictly adhere to the social distancing norms inside and outside the examination center.

Any candidate who is COVID positive and/or is undergoing isolation or quarantine process shall not appear for the Screening Test.


