The candidates will also be asked to make sentences using 5 (five) words which will carry 1 (one) mark each from each section. The duration of the test will be of 1 (one) hour.

Candidates are directed to bring the acknowledgement slip of online application, admit card of Common Written Examination (Afternoon Session) along with two recent passport sized coloured photographs. Without the admit card candidates will be debarred from appearing in the proficiency test. Candidates are directed to bring pen, pencil, clipboard etc. on the day of proficiency test.

Calling of the aforementioned candidates to the proficiency test is purely provisional and does not mean acceptance of their candidature, which shall be further scrutinized and the High Court reserves the right to reject the candidature of any candidate at any time. The candidature of the candidates shall be subject to fulfillment of all the criteria mentioned in the advertisement dated 6-8-2015. No TA/DA will be paid to the candidates.
