Pursuant to the Speed Test held on 9-8-2015(Sunday) in terms of the Notification No.HC.XXXVII-99/2013/840/R.Cell dated 30-07-2015, the Gauhati High Court has been pleased to prepare the following 2(Two) panels of serving Stenographers of District Courts of Assam, in order of merit, who have qualified the aforementioned Speed Test and accordingly found eligible for promotion to Stenographer Grade-I and Stenographer Grade-II respectively. In case of Stenographers securing equal marks, the Stenographer who is senior in age will be given preference over the Stenographer who is junior in age in the matter of promotion.
