Applications are invited from the eligible citizens of India as defined in Article 5 and 6 of the Constitution of India for filling up of 1 (one) post of Director in the establishment of the Law Research Institute, Gauhati High Court, Guwahati in the scale of pay Rs. 12,000-40,000/- p.m. with Grade Pay of Rs. 6,600/- plus other allowances as admissible under the Rules.

### **Minimum Educational Qualifications:**

- (i) A First Class Master's Degree in Sociology/Social Anthropology/Political Science/History (Ancient), and
- (ii) A Degree in Law.

**Experience:** A minimum of five (5) years experience in research work.

**Age:** The age of the candidates should not be less than 18 (Eighteen) years and more than 38 (Thirty Eight) years as on the date of advertisement. Upper age limit is relaxable by 5 (Five) years in case of candidates belonging to Scheduled Castes and Scheduled Tribes. In case of working personnel, upper age limit will be considered up to 50 (Fifty) years with a Doctorate Degree. 
