No T.A/D.A will be paid to the candidates for appearing in the examination.

If any applicant has any grievance regarding inclusion/non-inclusion etc. of his/her name in the published list of candidates, he/she may bring the same to the notice of the undersigned, in writing, during office hours within a period of 10 (ten) days from the date of publication of the list of candidates.

All the candidates will have to download and take printout of their Admit Cards from the official website of the High Court (www.ghconline.gov.in) w.e.f 3.00 pm of 31-8-2016 (Wednesday) till the date of the examination. The candidates shall bring the Admit Cards, along with black/blue ink ball point pen while appearing in the examination. Venue of the examination will be indicated in the Admit Card along with other details.
