The candidates shall bring to the Examination Hall the Admit Cards, while appearing in the examination. Venue of the examination will be indicated in the Admit Card along with other details. Allowing the candidates to appear in the written examination does not necessarily mean acceptance of their candidatures which shall be further scrutinized.


