1. Applications are invited from eligible candidates for filling up of 1 (one) post of Chief Security Officer (Gazetted) in the Principal Seat of the Gauhati High Court in the usual scale of pay of Rs. 12000-40000/-(P.B-4) with Grade pay of Rs.5400/- per month plus other allowances as admissible under the rules.

2. **ELIGIBILITY CRITERIA:**

The candidate shall have to be a retired Police Officer not below the rank of Deputy Superintendent of Police, or a serving officer from the State Police Service of an equivalent rank on deputation, or Officer from Military, Central Armed Forces and Central Armed Police Forces, who retired from service in the rank of Captain and Assistant Commandant etc. equivalent to the rank of Deputy Superintendent of Police in State Police Service. The person so appointed can continue in the post till he attains the age of 63 years or as per deputation Rules, as applicable, subject to continued suitability. Persons having knowledge of local language(s) will be given preference.

"Central Armed Forces" and "Central Armed Police Forces" means and includes Assam Rifles, Special Frontier Force, NSG; and CRPF, BSF, ITBP, CISF, SSB respectively.

3. **SELECTION CRITERIA:** Selection of candidate shall be made by conducting interview which will be notified in due course in the official website of the Gauhati High Court, viz. www.ghconline.gov.in.

4. **HOW TO APPLY:**

- i. The candidates have to submit the application form in the prescribed format mentioned below at **Annexure-I**. The application form should be typed and filled up in MS Word. Candidates are to print out the filled in Application Form and paste their recent passport size photograph in the space provided for and put their signature in the respective area. Thereafter, the candidates are to scan the said filled in application form and send the same as an attachment to the e-mail id ghcestt@gmail.com.
- ii. The candidates NEED NOT SUBMIT any testimonial/ certificate or any other document at this stage. Application along with the required original documents would be scrutinized at the time of interview/viva voce.
- iii. Incomplete/ incorrect applications or applications submitted through any other modes will not be entertained and will be summarily rejected. Applications received after the last date of submission will not be accepted under any circumstances.
- iv. Candidates must apply on or before **5.00 p.m. of 21.11.2016**.

5. OTHER TERMS AND CONDITIONS:

- i. Calling for interview will be purely provisional and subject to satisfying the prescribed eligibility conditions by way of furnishing documentary evidence in support of their candidature. If, on verification at any time before or after the selection process, it is found that a candidate does not fulfill any of the eligibility condition, his candidature shall stand cancelled without any notice. Mere calling of candidate to the interview or issuance of admit card / call letter etc. does not necessarily mean acceptance of candidature of any candidate, which shall be further scrutinized at every stage and the Gauhati High Court reserves the right to reject the candidature of any candidate at any time.
- ii. Before submitting applications, the candidate must possess a valid E-mail ID and the e-mail ID should remain active until the recruitment process is completed.
- iii. Interview will be held in the precincts of the Gauhati High Court at Guwahati.
- iv. No TA/DA will be paid for appearing in the interview.
- v. Candidates who are already in the Government Service may apply through proper channel. They shall have to produce release order from their present employer at the time of joining.
- vi. The High Court may decide not to issue admit card/call letter to any candidate and may decide to call candidates to the interview by publishing notification in the official website and notice board of the High Court.
