ORDER

No. LRI/01/75/3556/2016. Ms. Simlee Mandal is temporarily appointed as Court Attendant (Peon) in the Establishment of Law Research Institute, Gauhati High Court, Guwahati in the post created vide Govt. letter No. JDJ(E) 114/2003/85 dated 21.02.2014 in the usual scale of pay of Rs. 4560-15000/-(P.B-1) with Grade Pay of Rs 1500/- per month plus other allowances as admissible under the Rules with effect from the date of her joining.
