The Gauhati High Court has been pleased to dispense with the Preliminary Examination (Screening Test) for direct recruitment to Grade-I of Assam Judicial Service in terms of the Advertisement dated 12-1-2013 in view of less number of applicants. Main Written Examination-2013 for recruitment to Grade-I of Assam Judicial Service will be held in **Guwahati** as per the Schedule of Examination indicated herein.

Please note that candidature of the applicants shall be subject to fulfillment of all the criteria mentioned in the advertisement dated 12-1-2013. No T.A/D.A will be paid to the candidates for appearing in the written examination.

All the candidates will have to download and take Printout of their Admit Cards from the Official Website of Gauhati High Court (www.ghconline.gov.in) between **11.00 am of 19-3-2013(Tuesday) to 5:00 pm of 25-3-2013 (Monday)**. If any candidate fails to download the "Admit Card" from the website, he/she may contact in person the Recruitment Cell of the Gauhati High Court in Guwahati on **26-3-2013(Tuesday)** from **10.30 am to 4.00 pm**. On the day of the examination, the candidates shall bring their Admit Cards to the Examination Hall. Venue of the examination will be indicated in the Admit Card along with other details. Allowing the candidates to appear in the main written examination does not necessarily mean acceptance of their candidatures, which shall be further scrutinized.
