**NOTIFICATION**

If any candidate fails to download the "Admit Card" from the website, he/she may contact in person the Recruitment Cell of the Gauhati High Court in Guwahati on 6-9-2013(Friday) during office hours. The candidates shall bring to the Examination Hall the Admit Cards, along with black/blue ball point pen while appearing in the examination. Venue of the examination will be indicated in the Admit Card along with other details. Allowing the candidates to appear in the written examination does not necessarily mean acceptance of their candidatures which shall be further scrutinized and Gauhati High Court reserves the right to reject the candidature of any candidate at any subsequent time.


