Marks obtained in Assamese language segment will not be counted in preparing the merit list of written test. 				
Stage-2	Candidates in the ratio of 1:5, on the basis of performance in the written test (excluding Assamese language segment), will be called for the practical test of 20 marks and Interview/ Viva-Voce of 30 marks.				
Final select list will be based on the total marks obtained in the Written Test, Practical Test					

and Interview/Viva-Voce.

Note: In case of candidates obtaining equal total marks, one who obtains more marks in the practical test will be given preference. Where the marks obtained by such candidates in the computer practical test are also same, the candidate who is senior in age will be given preference.
